Following the successful inauguration of the Paralympic Awards in 2005, the awards will be held again in 2011 to honour members of the Paralympic Family for their exceptional performance and contributions to the Paralympic Movement. The 2011 Paralympic Scientific Award will recognize the work of one academic researcher for his/her contribution to research in the field of sports for persons with a disability.

This award will not only acknowledge and reward the work of researchers in this field but will also serve to promote and encourage further study and enhance the quality of work in this area. The award winner will be announced in early August 2011 and will be presented during a special ceremony held in conjunction with the 2011 VISTA Conference to be held in Bonn Germany, 31 August to 3 September 2011 (<a href="www.paralympic.org/events">www.paralympic.org/events</a>).

To be eligible for this award, candidates must have contributed through significant scientific publications related to the critical aspects of sport for persons with a disability in any discipline, have received national and/or international recognition and awareness of their work and place a specific emphasis on the practical application of research with direct or indirect benefit to the IPC. Candidates may be working in any related discipline at any level of study (undergraduate, post-graduate, academic, professional, scientific, practical).

This award also serves to promote and encourage further study in this area.

All nominations must be submitted to the IPC Headquarters by no later than 10 May 2011, 12:00 GMT.

From these nominations, the IPC Scientific Award selection committee will select the final winner.
